I would like to express my congratulations for the recent achievement of your company in completing the Goonyella Riverside Mine CPP1 1998 Yearly painting contract injury free.

As we discussed at our close-out meeting, the discipline of blasting and painting is recognised as having normally high injury rates due to the nature of the work, but although the work was carried out over a 10 week period we achieved over 8000 man hours of work, with zero minor injuries or LTI's. I believe this to be not luck, but a direct result of the attention that you paid to your pre-contract preparation and your daily monitoring once the work had commenced.
